



Adventures on The Gorge Official Contest Rules

These rules apply to the “Adventures On The Gorge” Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WKQC-FM (“Station”). **In addition, the General Contest Rules posted at www.k1047.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Monday, July 15, 2019 and end on Sunday, August 11, 2019.
- b. To participate in the Contest, visit www.k0147.com and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on Monday, July 15, 2019 at 12:00am Eastern Time (“ET”) and ending on Sunday, August 11, 2019 at 11:59pm ET (“Online Entry Period”). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. There will be up to a total of one (1) winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to one (1) Prize will be awarded in the Contest. The Prize consists of a vacation package at the “Adventures On The Gorge” West Virginia Adventure Resort in

Lansing, WV. Vacation Package includes a two (2) night stay in a 3-bed Sportsman Cottage for four (4) people (winner and three (3) guests); one (1) rafting trip for four (4) people on the Upper or Lower New River; four (4) passes for the Timbertrek Adventure Park; and two (2) Breakfasts, Lunches, and Dinners for four (4) people. Approximate Retail Value (“ARV”) of the Prize is \$1750. Prize is being provided courtesy of West Virginia Adventures On the Gorge.

- b. **WINNER IS SOLELY RESPONSIBLE FOR TRANSPORTATION TO/FROM LANSING, WV. STATION IS NOT RESPONSIBLE FOR ANY TRAVEL COSTS INCURRED AS PART OF THE WINNER’S AND GUEST’S TRANSPORTATION TO LANSING, WV. PRIZE TRIP MUST BE REDEEMED BY SEPTEMBER 7, 2020.**

- c. Actual value may vary and any difference between stated value and actual value will not be awarded. Certain restrictions may apply. All other costs not specifically stated herein, including but not limited to those of, taxes, meals, tips and transportation, baggage fees, hotel room service, laundry service, alcoholic beverages, merchandise, souvenirs, and local and long-distance telephone calls are the responsibility of the winner. If applicable, the winner may be required to present a valid credit card upon hotel check in to cover any incidental expenses incurred during the winner’s stay. Winner and guest must abide by all hotel, and venue policies. The winner and guest must sign all required releases prior to booking. If winner is unwilling or unable to travel on the dates specified, the prize will be forfeited and may be awarded to another winner at Station’s sole discretion. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station and prize provider, their sole responsibility to the winner will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). No refund or compensation will be made in the event of the cancellation or delay of any Prize-related Event. If winner chooses to take the trip without a guest, s/he will be awarded the prize elements for one person only, and the remainder of the prize will be forfeited without compensation. Winner understands that there are inherent risks involved in travel and that these risks may be present before, during and after the trip. **Winner will be issued a 1099 for 2019 regardless of when Prize trip is redeemed.**

Prize or prize certificate must be claimed within thirty (30) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner’s sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to one (1) Prize winner will be selected at approximately 9:00am ET on Monday, August 12, 2019 in a Station-conducted random drawing from all eligible online entries received during the Online Entry Period. Potential Prize winner will be notified by phone and/or email promptly following the random drawing.
- b. Odds of winning depend on the number of eligible online entries received during the Online Entry Period.
- c. Entrants need not listen to the Station or be present to win.
- d. Winner must confirm acceptance of prize within thirty (30) days of winning, or risk disqualification and selection of an alternate winner (time permitting) in a random drawing of all remaining eligible entries.
- e. Decisions of Station management with respect to the Contest are final.
