



2024 K104.7 Jamaican Me Crazy For Cash Official Contest Rules

These rules apply to the “Jamaican Me Crazy For Cash” Contest (“Contest”) conducted by Beasley Media Group, LLC d/b/a WKQC-FM (“Station”). In addition, the General Contest Rules posted at www.k1047.com apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.

1. HOW TO ENTER

- a. The Contest will begin on Thursday, January 4, 2024 and end on Thursday, January 25, 2024.
- b. To enter on-air, listen to the Station each weekday beginning on Thursday, January 24, 2024 and ending on Thursday, January 25, 2024 at approximately 8:25am Eastern Time (“ET”) for the announcement of the daily “Keyword”. Each weekday will have a unique Keyword. Then, entrants must listen to the Station at approximately 4:25pm ET for the announcement of the cue to call. Upon hearing the cue to call, the designated number caller (as announced on-air at the time of the cue to call) to the Station contest line at 704-570-1047 will have the opportunity to win a Qualifying Prize and be qualified for a chance to win the Grand Prize (each deemed a “Qualifier”) by correctly identifying the daily Keyword announced that morning, upon confirmation of eligibility. Station will be the sole judge in determining if the designated caller correctly identified the daily Keyword. Station is not responsible for any failure of a caller to reach the Station contest line including but not limited to busy phone lines, misdirected calls, equipment breakdowns, or disconnections. Calls will only be accepted at the designated phone number. At the time of entrant’s call, entrant will be required to provide all information requested including entrant’s full name, complete address (including zip code), day and evening phone numbers and date of birth in order to be eligible to win. P.O. Boxes are not permitted. In the event that the selected caller is disconnected, incorrectly identifies the daily Keyword, or is found to be ineligible, the next eligible caller who successfully makes it through on the call-in line, correctly identifies the daily Keyword, and completes the call will be a Qualifier. There is no limit to the number of times a listener may attempt to call in

to win, but a listener may be a Qualifier only once.

- c. There will be up to a total of sixteen (16) Qualifying Prize winners and one (1) Grand Prize winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 21 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in North or South Carolina, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.

3. PRIZES

- a. Up to sixteen (16) Qualifying Prizes will be awarded. Each Qualifying Prize consists of a company check issued in the name of the winner in the amount of two hundred and fifty dollars (\$250). The Approximate Retail Value (“ARV”) of each Qualifying Prize is \$250.

No check will be awarded, processed or mailed until winner has claimed the prize at the Station, presented all required documentation, and signed all required releases and tax forms. Checks will then be mailed within approximately six (6) to eight (8) weeks following confirmation of eligibility and completion of all requisite releases and IRS forms.

- b. Up to one (1) Grand Prize will be awarded. Accommodations are valid for one (1) room double occupancy, king size bed deluxe room, all meals, unlimited premium brand liquors, daily & nightly entertainment, an array of land and water sports activities, including daily scuba diving (for certified divers), snorkeling, Wi-Fi in all rooms and public areas, resort taxes, resort gratuities, and Sandals Resorts transfers to and from the resort's designated airport.

Round-trip coach airfare for two (2) adults valid to/from the nearest major U.S. gateway of the prize winner to the selected or designated resort's airport. The tickets are valid until from January 31, 2024 – January 31, 2025 (the "Redemption Period") and are subject to availability and black-out periods. Flights will be on mutually approved dates. - c. Odds of winning a Qualifying Prize on-air depend upon the number and order of calls received. Odds of a Qualifying Prize winner winning the Grand Prize are up to 1 in 16.
- d. Entrants must listen to the Station to win a Qualifying Prize but do not need to be present to enter or win a Qualifying Prize. The Qualifying Prize winners do not need to listen to the Station or be present to win the Grand Prize.
- e. Grand Prize winner must confirm acceptance of prize within 7 days of winning, or risk disqualification and selection of an alternate Grand Prize winner (time permitting) in a random drawing of all remaining Qualifiers.
